

# **Metals Studio Intern Application**

# General Information about being an Intern at JCGEP:

JCGEP is a business incubator project that uses methane from the Dillsboro landfill to support emerging artists. Artists and students may apply for an internship position with JCGEP, which will provide unique educational opportunities involving forges and other metal-working equipment, their operation and maintenance, interacting with the public, marketing, and studio management. JCGEP is located in Dillsboro, NC, roughly 1 hour's drive west of Asheville, NC. JCGEP is a county-run facility. Therefore additional responsibilities include: following the Park and/or the county's rules and guidelines; maintaining a clean and safe workspace at all times; maintaining a respectable appearance and demeanor when interfacing with the public; and maintaining a good working relationship with Park staff and other residents. Interns, volunteers, and staff of JCGEP share in a rotating studio schedule during hours in which the park is open to the public, as well as assist with tours, workshops, and onsite classes.

#### **Duties**

- Assist with/perform metal equipment maintenance and repairs, maintain welding equipment, set up and operate gas equipment.
- Maintain metal shop cleanliness and order; clean and maintain tools.
- Assist with public tours, demonstrations, and gallery shows.
- Assist with marketing activities and classes.
- Other duties as required.

- Assist and learn from experienced JCGEP artists.
- Learn about using renewable fuels to create art.
- Experience collaborative efforts working with artists from different mediums.
- Opportunity to sell artwork through JCGEP's gallery.
- Gain shop time in trade for working hours.

- Gain valuable experience working with professional artists and working for an arts organization.

### Schedule

• Interns will work a flexible, 10 - 20 hour per week schedule. Some evening and/or weekend work may be required. Since most interns will have to secure part-time employment to pay for living expenses, we will be as flexible as possible to accommodate their work schedules. Adequate time off will be provided to allow interns to take advantage of the many outdoor and cultural activities available in the region.


